# THE VERIZON ACCESS CONCERT SERIES SWEEPSTAKES - HOUSTON OFFICIAL RULES

# NO PURCHASE NECESSARY. A PURCHASE WILL NOT INCREASE YOUR CHANCES OF WINNING. VOID WHERE PROHIBITED

The VERIZON ACCESS CONCERT SERIES SWEEPSTAKES - HOUSTON ("Sweepstakes") begins on October 9, 2024, at 12:00 a.m. Central Time (CT) and ends on October 21, 2024, at 11:59 p.m. CT (the "Sweepstakes Period"). By participating in the Sweepstakes, each entrant unconditionally accepts and agrees to comply with and be bound by these Official Rules and the decisions of Verizon Corporate Services Group Inc. ("Sponsor") and Rio Creative, Inc. ("Administrator"), which are binding and final in all respects.

## 1. ELIGIBILITY

The Sweepstakes is open to individuals who: (i) are at least 18 years of age at the time of entry in the Sweepstakes; (ii) are legal residents of the state of Texas; and (iii) are NOT in one or more of the "Prohibited Persons" categories listed below. Any entry submitted by any ineligible person(s) will be void.

<u>Prohibited Persons</u>. Entries must be received by 11:59:59 p.m. ET on October 21, 2024. Data usage rates may apply to access the Sweepstakes microsite.

## 3. CONDITIONS APPLICABLE TO ALL ENTRIES

Limit one entry per person and per email address during the Sweepstakes Period. Sponsor's computer is the official time-keeping device for the Sweepstakes. All received entries become the exclusive property of Sponsor and will not be acknowledged or returned, and no correspondence will be entered into. Any attempt by an entrant to obtain more than the stated number of entries by using multiple/different email addresses, identities, registrations and/or logins, or any other methods will void that entrant's entries and that entrant may be disqualified if discovered by Sponsor or Administrator. The use of automated entry devices or any other conduct that impedes the integrity of the Sweepstakes is prohibited. On the thirteenth day, twenty-four (24) potential prize winners will be selected via random drawing by an independent judging organization, selected by Sponsor in its sole discretion, from among all eligible Entries received during the Sweepstakes Period. Any entries not selected during a particular drawing will be rolled over into subsequent drawings.

Potential prize winners must meet all eligibility requirements and comply with these Official Rules to qualify for the prize. The judging organization's decisions are final on all matters relating to the drawing. Limit one prize per person during the Sweepstakes Period.

#### 5. PRIZES / ODDS OF WINNING

Administrator will attempt to notify potential winners via email and/or phone, using information provided on the Entry form. Potential winners will be required to follow prize claim instructions provided and return all necessary prize claim documents within forty-eight (48) hours from the date of notification. Potential winners must complete and sign a Prize Acceptance & Liability Waiver and a Publicity Release before the Prize will be awarded. The Prize will be forfeited in the event that: (i) the potential winner is not in compliance with

these Official Rules, including any eligibility requirements; (ii) the prize notification or attempted notification is returned as undeliverable; (iii) Sponsor does not receive timely response to prize notification; or (iv) a potential winner declines the Prize offered.
